This Privacy Policy is in place to help you better understand how we maintain data and what we do to protect your information. Our services are primarily offered through a software platform which is distributed on multiple URLs and servers.

We also use have integrations with third-party companies and financial institutions to facilitate more efficient and effective transactions. Nomad does not hold or control funds for other companies or individuals. Nomad is not a money transmitter or e-money service business. Nomad offers consulting and software services.

The sites and services offered by Nomad are for the use of our clients and service partners.

All information collected is done pursuant to contractual obligations necessary to carry out services provided to you. Your use of the services is your consent to be bound by this policy. It is also your consent to abide by the Terms and Condition of Nomad. We also contract with third party providers to provide services and benefits and they have their own privacy policies you may review as you feel necessary.

We collect personal information needed to operate the services that you choose to utilize, and to assist in the functionality of the related supporting services provided on our platform. By using our platform(s) you authorize us to verify your identity and eligibility to participate in our services as determined by government agencies and networks which are either used by our platform or by our service providers, or subject to related laws and regulations. We update our records, programs, functions and policies from times to time as required and necessary. We do not send notices out each time we add a service or add additional countries. We do post our policies online and you may review then as you deem necessary.



PRIVACY POLICY

We collect personal input by you to operate our platform for our clients. The information used is commercially necessary for the operation of the platform. We only collect information we deem to be necessary and essential to the effective operation of our platform. We do not sell your information. We use the data for legitimate business reasons only. Various countries have different requirements, and we endeavor to use commercially viable means to reasonably ensure we are in compliance. Information may be shared with clients and service providers to complete the necessary tasks for our business needs. We may also conduct internal audits or require information to help with troubleshooting or trace a particular transaction to better serve you.

You may withdraw your consent at any time and discontinue our services. If you choose not to share certain information, it may prevent us from providing a service, and we may remove you from our system or refuse service.

We take commercially reasonable steps to protect your data. We also implement policies and procedures to protect data and use. We limit access only to those who need said information. It is in the exclusive discretion of Nomad on how and when information can be collected or shared or disseminated in order to best fit the needs of Nomad.

We comply with policy and regulations to protect children. If you're under the age of 13 you may not provide any information or use the services we provide. Should we learn of this, we reserve the right to terminate your account and delete your information without parental consent. If you do not agree with this policy, then do not use this service.
